2013 Model Year Honda Fit Passenger Side Driveshaft

Dear Ms. Lewis:

On May 8, 2014 Honda Motor Co., Ltd. (HMC) determined that a potential defect relating to motor vehicle safety exists in the Drive Shaft of certain 2013 model year Honda Fit automobiles, and is providing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Noncompliance Reports.

The recall population was determined based on manufacturing records. The VIN range reflects all possible vehicles that could potentially experience the problem.

Percentage of affected vehicles that contain the defect:

Unknown

Defect description:

During manufacturing of the passenger side driveshaft, it is possible that the heat treatment process was not properly applied, resulting in the driveshaft having a lower hardness level that is outside of the design specification. A driveshaft exhibiting lower hardness could break while driving, increasing the risk of a crash.

Chronology:

October 31, 2013

Honda was notified of a broken driveshaft claim outside of the United States.

January 29, 2014

Honda began defect investigation on the broken driveshaft claim.

March 14, 2014

Honda determined that the broken driveshaft was due to insufficient quenching of the driveshaft material. Honda, at this time, viewed the claim as a singular occurrence.

March 21, 2014 - April 4, 2014

Honda was notified of three additional occurrences of broken driveshaft claims outside of the United States.

April 10, 2014

Investigation of the driveshaft manufacturing process indicated that the process may not have been completed properly.

April 17, 2014

Honda determined that the three additional broken driveshaft claims from outside of the United States were due to insufficient heat treatment of the driveshafts. At the time, Honda did not recognize that United States vehicles were affected by this condition.

May 8, 2014

Honda determined that a safety defect exists and decided to conduct a recall.

As of April 30, 2014, Honda has received 1 warranty claim and no injuries within the United States related to this issue.

Program for remedying the defect:

The owners of all affected vehicles will be contacted by mail and asked to take their vehicle to a Honda automobile dealer. The dealer will inspect the passenger side driveshaft and if necessary, replace it free of charge.

Because the new vehicle warranty on all affected vehicles would have provided a free repair for the problem addressed by this recall, without any payment by the owner, reimbursement for pre-notification repairs will not be offered.
