Description of the Defect : General Motors has decided that a defect, which relates to motor vehicle safety, exists in certain 2014 model year Chevrolet Silverado 1500 and GMC Sierra 1500 vehicles, and 2015 model year Cadillac Escalade and Escalade ESV; Chevrolet Silverado HD; and GMC Sierra HD, Yukon, and Yukon XL, equipped with a 4.3L engine, 5.3L engine, 6.0L engine or 6.2L engine. When these vehicles are idling in cold temperatures, some of the exhaust components may overheat. If this were to occur, the yellow Check Engine light will illuminate and the "Engine Power is Reduced" message will appear in the Driver Information Center (DIC).

Description of the Safety Risk : If there is enough heat, it could melt plastic parts in the area, resulting in a possible engine fire.
