**Description of Defect :**

Description of the Defect : Ferrari North America, Inc. (Ferrari) is recalling certain model year 2010-2014 458 Italia and 458 Spider vehicles manufactured March 5, 2010, to May 20, 2013. The affected vehicles may experience the front trunk storage compartment latch system not releasing the secondary latch when the vehicle is stationary. Thus, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standards No. 401, "Interior Trunk Release."

Description of the Safety Risk : In the event an individual is trapped in the trunk and the latch system does not release the trunk lid, it increases the risk of personal injury or possibly death.

**Chronology :**

As a result of Ferrari's recent determination of a noncompliance with another FMVSS (which was reported to NHTSA on July 16, 2014), Ferrari started an internal review of the compliance status of its vehicles with other FMVSSs. As a result of this review, Ferrari identified a running change that was made to the front trunk latch in May 2013. Upon further review, Ferrari determined that the vehicles manufactured prior to the running change did not comply with S4.3(b)(1)(i) of FMVSS No. 401, in that the latch system does not release the secondary latch when the vehicle is stationary. In all operating conditions, the latching system works properly to release the front trunk lid from the primary latching position.

**Description of Remedy :**

Description of Remedy Program : Ferrari will notify owners, and dealers will modify the existing front trunk latch system with a new component that will meet requirements, free of charge. Manufacturer has not yet provided a notification schedule. Owners may contact Ferrari customer service at 1-866-788-6760. Ferrari's number for this recall is 54.
