Description of the Defect : General Motors LLC (GM) is recalling certain model year 2011-2014 Chevrolet Express vehicles manufactured September 10, 2010, to April 28, 2014, and GMC Savana vehicles manufactured May 23, 2011, to April 21, 2014 equipped with CNG tank. The affected vehicles may experience a natural gas leak coming from the CNG high pressure regulator.

Description of the Safety Risk : If there is a natural gas leak, that will increase the risk of a vehicle fire or explosion in the presence of an ignition source.
