This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Ford Motor Company has decided that a defect which relates to motor vehicle safety exists in your vehicle, with the Vehicle Identification Number shown above.

We apologize for this situation and want to assure you that, with your assistance, we will correct this condition. Our commitment, together with your dealer, is to provide you with the highest level of service and support.

| What is the issue?                    | Your vehicle may have been serviced with a steering gear containing a software error. Due to this error, if certain component faults were to occur, the steering gear would become locked. A locked steering gear would not allow an operator to steer the vehicle, increasing the risk of a crash. |

| What will Ford and<br>your dealer do? | Ford Motor Company has authorized your dealer to replace the steering gear free of charge (parts and labor).  |
| How long will it take?                | The time needed for this repair is less than one-half day. However, due to service scheduling requirements, your dealer may need your vehicle for a longer period of time.  |
| What should you do?                   | Please call your dealer without delay and request a service date for Recall 13S14. Provide the dealer with the Vehicle Identification Number (VIN) of your vehicle. The VIN is printed near your name at the beginning of this letter.  |
