

IMPORTANT SAFETY RECALL

This notice applies to your vehicle (VIN: xxxxxxxxxxxxxx).

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Chrysler has decided that some **2014 model year RAM 5500 trucks** fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 567 – Certification.

The problem is... The Certification and Supplemental Tire Pressure Information label on your truck fail to conform to the requirements of Federal Motor Vehicle Safety Standard (FMVSS) No. 567, "Certification". The labels contain incorrect vehicle weight rating and incorrect payload value on the supplemental tire pressure label. This can cause improper loading of the vehicle and cause a crash without warning.

What you must
do to ensure your
safety...> We ask that you apply the enclosed Certification label and Supplemental Tire
Pressure Information label so that they cover the existing labels as described
on the reverse side of this letter.

If preferred, you may contact your dealer to schedule a service appointment for installation of the labels. The service will be provided free of charge and should only take a few minutes to complete. However, additional time may be necessary depending on service schedules. Bring the enclosed labels and this letter with you to your dealer. The letter identifies the required service to the dealer.

Installation Instructions for Certification and Tire Pressure Labels

- 1. Open the driver's door and locate the Certification label on the driver's door as shown in Figure 1.
- 2. Clean the existing Certification label with alcohol / glass cleaner or equivalent and a soft cloth to remove any dirt, oil residue or grease.
- 3. Remove the enclosed Certification label from its paper backing and carefully install it over the existing Certification label (Figure 1). Firmly press and smooth the label to the surface of the existing Certification label to ensure good adhesion.
- 4. Locate the Supplemental Tire Pressure Information label on the driver side B-post above the door striker as shown in Figure 1.
- 5. Clean the existing Supplemental Tire Pressure Information label with alcohol / glass cleaner or equivalent and a soft cloth to remove any dirt, oil residue or grease.

- 6. Remove the Supplemental Tire Pressure Information label from its paper backing and carefully install it over the existing label (Figure 1). Firmly press and smooth the label to the surface of the existing Supplemental Tire Pressure Information label to ensure good adhesion.
