Triple E Recreational Vehicles Recall CA#7841-1

This notice is sent to you in accordance with the requirements of the National Traffic & Motor Vehicle Safety Act. Triple E Recreational Vehicles has decided that certain 2014 Free Spirit Travel Vans manufactured between September 2013 & March 2014 fail to conform to Federal Motor Vehicle Safety Standard No. 108, “Lamps, Reflective Devices, and Associated Equipment

### **Description of Noncompliance:**

The spare tire & spare tire cover may obstruct the visibility of the rear driverside taillight. When in motion, vehicles following may not see the intention of the driver during left hand turns, increasing the risk of a crash.

### **To Have This Modification Performed:**

We request your assistance to have this noncompliance issue corrected. Your selling dealer will perform the needed correction. The tire carrier will be replaced with a new tire carrier. Please contact your selling dealer as soon as possible to arrange for an appointment to have this recall performed. The recall will be performed at no charge to you. The time needed to complete this repair is approximately 1 hour.

**Federal regulations require that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.**

**If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.**
