

IMPORTANT SAFETY RECALL**P13 / NHTSA 14V-161**

This notice applies to your vehicle (VIN: xxxxxxxxxxxxxxxxxxxx).

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Chrysler has decided that a defect, which relates to motor vehicle safety, exists in some **2014 model year RAM trucks**.

The problem is... **The transmission case on your truck may have improperly machined park rod guide plate mounting surfaces. This could cause a loss of park rod guide plate fastener clamp load and eventually the park rod guide plate fasteners may loosen. A loose guide plate and fasteners may not allow the park pawl to fully engage. This condition could cause unintended vehicle movement and cause a crash without warning.**

What your dealer will do... **Chrysler will repair your vehicle free of charge (parts and labor).** To do this, your dealer will inspect the transmission case and replace the transmission assembly if required. The transmission case inspection will take about 1½ hours to complete. If the transmission requires replacement an additional 4 hours will be required. However, additional time may be necessary depending on service schedules.

What you must do to ensure your safety... Simply **contact your Chrysler, Jeep, or Dodge dealer** right away to schedule a service appointment. **Please bring this letter with you to your dealer.**

Box 21-8007, Auburn Hills, MI 48321-8007, Attention: Reimbursement. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days.
