## Safety Recall Notice 14S15 / NHTSA Recall 14V-482 Aviso de Revisión de Seguridad 14S15

2015 T-150 Ford Transit Your Vehicle Identification Number:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Ford Motor Company has decided that a defect which relates to motor vehicle safety exists in your vehicle, with the Vehicle Identification Number shown above.

We apologize for this situation and want to assure you that, with your assistance, we will correct this condition. Our commitment, together with your dealer, is to provide you with the highest level of service and support.

What is the issue?	On your vehicle, it may be possible for the rear brake hose to leak brake fluid. If any of the brake hoses are leaking, the driver of the vehicle would experience illumination of the red brake warning lamp, longer pedal travel, and extended stopping distance. In the event that both circuits leak simultaneously, there will eventually be a complete loss of service brake effectiveness. Reduction of service brake effectiveness and extended stopping distance increase the risk of a crash.
What will Ford and your dealer do?	Ford Motor Company has authorized your dealer to replace the rear brake hose washers free of charge (parts and labor).
How long will it take?	The time needed for this repair is less than one-half day. However, due to service scheduling requirements, your dealer may need your vehicle for a longer period of time.
What should you do?	Please call your dealer without delay and request a service date for Recall 14S15. Provide the dealer with the Vehicle Identification Number (VIN) of your vehicle. The VIN is printed near your name at the beginning of this letter.

If you do not already have a servicing dealer, you can access www.Fordowner.com for dealer addresses, maps, and driving instructions. Ford Motor Company wants you to have this safety recall completed on your vehicle. The vehicle owner is responsible for making arrangements to have the work completed. Ford Motor Company can deny coverage for any vehicle damage that may result from the failure to have this recall performed on a timely basis. Therefore, please have this recall performed as soon as possible. Please note: Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days. If you no longer own this vehicle, and have an address for the current owner. What if you no longer own this please forward this letter to the new owner. vehicle? You received this notice because government regulations require that notification be sent to the last known owner of record. Our records are based primarily on state registration and title data, which indicate that you are the current owner.
