IMPORTANT SAFETY RECALL NOTICE

Dear Acura RLX Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

What is the reason for this notice?

Acura has decided that certain 2014-2015 model year RLX vehicles fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 108 "Lamps, Reflective Devices and associated equipment." The headlight reflector material may not be properly adhered allowing it to peel off of the reflector, affecting headlight performance and your ability to see at night, increasing the risk of a crash.

What should you do?

Parts needed to complete this repair will become available in Spring 2015. Honda will send you another letter when those parts become available.
