Dear Peterbilt Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Peterbilt Motors Company has decided that a defect which relates to motor vehicle safety exists in certain 2014- 2015 Model 220 vehicles that were manufactured between December 05, 2013 and October 10, 2014 and are equipped with a quick release and double check (QRDC) valve. In affected trucks with a Wabco quick release valve with double check valves, used to control park/spring brake application, the valve may leak internally.

This could cause unintended partial or full park/spring brake application, which could affect service brake function and increase the risk of a crash. Also, dragging brakes could result in overheated components, increasing the risk of a fire. These issues could cause injury and/or damage to property.

<i>What you must do ...</i>	Contact your dealer immediately to schedule an appointment

Peterbilt has initiated a recall to remedy the defect free of charge. Please contact your nearest Peterbilt dealership to confirm parts are available before scheduling this repair. This repair should take approximately 1.0 hours, and will be performed at no charge to you. 
