**Descriptive Information :** Haldex reported (3) Life Seal NG3 brake chambers with defects. Part numbers are 1533030002, 1533030007 and 1533030020. They initially filed recall for limited production but then resubmitted to replace all (3) Life Seals above with Gold Seals line products.

**Defect:** Small internal air leak which bleeds air from the Spring brake side to the Service Brake side causing a possible brake brag condition.

**Consequence:** Brake failure which may cause accident. Haldex has already filed the above to NHTSA, campaign number 14E075000. Hyundai is submitting a Vehicle recall to follow regulations with NHTSA. VIN list of potential units affected attached.
