Description of the Safety Risk: If enough fluid were lost, the brake system warning light and a "Check Brake

Fluid" message in the Driver Information Center would illuminate (in rare cases, the brake hose may rupture suddenly without prior warning), and vehicle stopping distance may increase. If stopping distance is limited, a crash

could occur.

## **Chronology:**

In response to a customer complaint regarding front brake hose corrosion on a model year 2004 Cadillac CTS-V, GM opened an investigation of front brake hose corrosion in CTS-V vehicles on February 18, 2015. As part of this investigation, GM determined that model year 2004-2007 CTS-V vehicles share the same brake hoses as certain model year 2003-2007 CTS vehicles which were previously recalled per Safety Recall 09149B (10V-105). This prior safety recall was conducted in 2009 for front brake hose corrosion on model year 2003-2007 Cadillac CTS vehicles in corrosion-susceptible areas. On April 7, 2015, GM's Safety Field Action Decision Authority decided to conduct a safety recall for these vehicles by adding this population to the prior safety recall.

### **Description of Remedy:**

Description of Remedy Program : Dealers are to replace both front brake hose assemblies. Pursuant to 577.11,

General Motors will provide reimbursement to owners for repairs according to the plan submitted on May 23, 2013.

How Remedy Component Differs from Recalled Component: The new brake hose design removed the routing

sleeve in order to eliminate the possibility of water/salt deposits which can cause corrosion. The brake hose's metal tubing was also extended to provide the structural support previously

provided by the routing sleeve.

Identify How/When Recall Condition was Corrected in Production : New front brake hose assemblies were

previously designed and implemented in production and service in 2010 as a result of the model year 2003-2007 CTS recall. Those corrective hose assemblies have been available for service installation on CTS and CTS-V vehicles since 2010, and

they remain available at this time for all recalled model year 2004-2007 CTS-V vehicles.
