updated by dealers with a new software version which inadvertently made the front side marker lamps inoperative. As a result, the front side marker

lamps do not illuminate in conjunction with the parking lamps or

headlamps and no warning message is displayed in the instrument cluster.

Therefore, affected vehicles do not conform to FMVSS 108 "Lamps,

reflective devices, and associated equipment". The turn signal function of

the front side marker lamps remains operational.

## **Chronology:**

On July 24, 2015, BMW became initially aware of this concern through routine checks of its Technical Service measures. It was found that both front amber parking lamps were no longer illuminated in conjunction with the headlamps after programming a customer's vehicle with an updated software version, which had been released to the dealer network on June 15, 2015. Initial analyses pointed to a possible bug in this new software version.

On July 29, 2015, a service information bulletin was released to BMW dealers, instructing them not to perform any programming or coding on potentially affected customer vehicles until a revised software version becomes available, which was subsequently released on August 3, 2015.

Further analyses were performed to determine the quantity and production date range of the potentially affected vehicles.

On August 6, 2015, it was determined that vehicles programmed with this software version do not fully conform to FMVSS 108. As a result, BMW decided to conduct a voluntary recall.

BMW has not received any reports, nor is BMW otherwise aware, of any accidents or injuries related to this issue.
