Chronology:

• On August 26, 2013, DS quad cab compliance to FMVSS 226 began.

- On July 27, 2015, the National Highway Transportation Safety Administration ("NHTSA") informed FCA US that on July 22, 2015 it had tested a 2015 MY DS Quad Cab pickup for compliance to FMVSS 226, at MGA Research in Troy, MI. NHTSA indicated the vehicle failed at the driver-side lower most rearward target location. 2015 MY "AI" level SABICs were installed in the vehicle.
- On August 12, 2015, the NHTSA visited FCA US' Auburn Hills complex to witness a FMVSS 226 compliance test on a 2015 MY DS Quad Cab pickup. The vehicle failed the driver-side and passenger-side lower most rearward target locations. 2015 MY "AI" level SABICs were installed in the vehicle.
- On August 13, 2015, FCA US tested a 2014 MY DS Quad Cab pickup. The vehicle failed the passenger-side SABIC lower most rearward target location.
- On August 18, 2015, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.
- On August 19, 2015 engineering determined that the rear cushion index was the primary root cause of the failure
- On September 1, 2015 engineering completed testing on a proposed solution that would require an inspection on the SABIC and introduce foil patches to the headliner. This solution required the replacement of any SABICs that could not be remedied by the foil patch introduction alone.
- On September 1, 2015 engineering concluded testing that confirmed that for all incidences where a foil patch was introduced, the SABIC met all FMVSS 226 requirements.
- On September 18th, 2015 FCA US launched the dealer instructions for inspection and repair.

Description of Remedy:

Description of Remedy Program : A foil patch will be installed on both sides of the headliner. Your dealer will also inspect the right and left Side Airbag Inflatable Curtains for proper orientation. In a small number of cases, one or both of the Side Airbag Inflatable Curtains may need to be replaced.

FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
