# **Chronology:**

\*\* 2016 03 01 ¿ In December 2015, FCA US engineering notified the FCA US VSRC that the RAM 1500 ("DX") did not have the same track bar design and should be removed from the R46 campaign. ¿ On February 16, 2016, the FCA US VSRC confirmed that the RAM 1500 ("DX") did not contain

the defect.

¿ On February 17, 2016, the FCA US VSRC communicated RAM 1500 ("DX") change to NHTSA's

ODI.

¿ In December 2015, FCA US engineering notified the FCA US VSRC that the Power Wagon ("DJ") did not have the same track bar design and was welded in a different cell than the suspect R46 vehicles.

¿ On February 29, 2016, the FCA US VSRC confirmed that the Power Wagon ("DJ") did not contain the defect, notified NHTSA's ODI of the change, and, per an FCA US engineering communicated discussion, removed Power Wagon ("DJ") vehicles from the population as it was not of the same design as vehicles included in the R46 campaign.

On August 18, 2015, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

#### **Description of Remedy:**

Description of Remedy Program: 11/17/2015: As an interim measure, FCA US will inspect any vehicle affected by this recall to determine if the OEM Track Bar Bracket shows evidence of the defect condition. If a vehicle passes the inspection (i.e., shows no evidence of cracks or failed welds relating to the defect condition), the recall shall remain "open" for such vehicle. VINs of vehicles passing inspection will continue to be included in the Final Remedy plan. The final remedy will be a clam shell reinforcement bracket mechanically attached over the OEM Track Bar Bracket, when available (estimated first quarter 16CY). If, prior to availability of the final remedy, the vehicle exhibits any symptoms consistent with a failed or failing Track Bar Bracket, an owner should bring his/her vehicle back to the dealer for another inspection.

> If, upon inspection, cracks or failed welds relating to the defect condition are identified, a new welded Track Bar Bracket will be installed on the vehicle. For vehicles receiving a new welded Track Bar Bracket, the recall shall be marked "complete." VINs of vehicles failing inspection and receiving a new welded Track Bar Bracket will not be included in the Final Remedy plan.\*\*

FCA US will conduct a voluntary safety recall on all affected vehicles; remedy will be documented once testing is complete.

FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
