vehicles where the owner's handbook information, which details the functionality of the Airbag Status Indicator Lamp, has been incorrectly described. Actual operation of Occupant Sensor System (OSS) is not affected, however the description of operation in the owner's handbook does not correspond with the actual Airbag Status Indicator Lamp operation. Vehicles with the handbook in this condition will not comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) 208 – Occupant Crash Protection.

### **Chronology:**

Engineering reviews of draft 2016MY handbook descriptions identified that the operation of the Airbag Status Indicator Lamp differed to the actual operation of the system. Jaguar Land Rover under took a thorough review of all previous hand book descriptions for this system operation and confirmed that this anomaly only exists for certain 2014MY vehicles. 2015MY hand book description was reviewed at 2015MY vehicle introduction and is correct to system operation.

Jaguar Land Rover investigations identified the concern was linked to the introduction of a functional change where the Airbag Status Indicator Lamp was incorporated into a new roof console system.

The Senior Review Panel reviewed the concern on September 3, 2015, and concluded that the condition represented a non-compliance with FMVSS 208 and that a non-compliance recall action is launched to remedy all the affected vehicles.

There have been no reports of accidents or injuries as a result of this concern.
