Description of the Defect : Reference Fontaine Recall 15E-066

Fontaine Fifth Wheel Company (Fontaine) is recalling certain Ultra LT Fifth Wheel connectors, part number SLTPL4000, manufactured July 29, 2009 to May 27, 2013. Over time, improper coupling techniques may result in cumulative damage to the fifth wheel and its locking mechanism, which in turn may result in the locking mechanism failing to operate or to properly engage.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : If the fifth wheel and locking mechanism are sufficiently damaged, the locking mechanism may fail to operate as intended and the trailer may unexpectedly detach from the tractor, increasing the risk of a crash. Volvo has not received reports of vehicle crashes.
