Description of Remedy Program : FCA US will conduct a Voluntary Safety Recall on all affected vehicles to seal the ground eyelets with dual wall heat shrink, repair the Headlamp and Dash Wiring Harness as required and replace the ABS Module as necessary. FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
