October 2015: During routine testing of a future model vehicle with this trailer braking system option, it was observed that the trailer brakes were not actuating when the vehicle brakes where applied. The 2016 MY 6.8L E-Series Cutaway / Chassis Cab vehicles with trailer brake controllers were verified to exhibit the same condition. A "stop ship" action was initiated and this topic was reviewed by Ford's Critical Concern Review Group (CCRG).

On October 19, 2015 Ford's Field Review Committee reviewed the concern and approved a field action.

Description of Remedy:

Description of Remedy Program: Owners will be notified by mail and instructed to take their vehicle to a Ford

or Lincoln dealer to reprogram the powertrain control module using the normal Integrated Diagnostic System procedure. There will be no charge for

this service.

Ford is excluding reimbursement for costs because the original warranty

program would provide for a free repair for this concern.
