Description of Defect :

Description of the Defect : According to the Part 573 Report filed by Lippert Components, Inc. (Lippert), 15E078, potential structural fracture of the center bolt of the fan gear assembly may cause the fan gear assembly to disengage from the steps.

The step part numbers are; 128980; 64194; 165033; 165034; 165035; 165044; 168367; 171317; 171776; 173476; 234310.

Description of the Safety Risk : According to the Part 573 Report filed by Lippert, 15E078, if the center bolt of the fan gear assembly fractures, the fan gear assembly may disengage from the steps making the steps unstable, possibly causing a person to fall and resulting in injury.

Description of the Cause : According to the Part 573 Report filed by Lippert, 15E078, the bolt may fracture from stress on the bolt caused by misuse of the steps, overloading, collision, or other outside influences.

Identification of Any Warning that can Occur : According to the Part 573 Report filed by Lippert, 15E078, the steps do not fully retract under the motorized recreational vehicle, or there could be no warning prior to the bolt fracture.

Chronology :

According to the Part 573 Report filed by Lippert, 15E078, NHTSA opened an investigation (PE 15-007) of three step electric powered entry steps on February 27, 2015. On March 3, 2015 Lippert received the Preliminary Evaluation PE 15-007 to investigate allegations of entry step failures in certain model year 2008 through 2014 steps. On September 11, 2015, Lippert Components decided to conduct a safety recall of all double and triple Coachstep electric entry steps.

Forest River's Office of Corporate Compliance ("OCC") was notified of Lippert's safety recall by Lippert (CHECK TO BE SURE THIS IS ACCURATE) on November 10, 2015. OCC initiated its own internal investigation of the issues raised in Lippert's safety recall and the VIN numbers potentially affected by the Lippert recall. Forest River's Corporate Recall Committee met on November 16, 2015 and concluded that Forest River needed to participate in the recall.

Description of Remedy :

Description of Remedy Program : According to the Part 573 Report filed by Lippert, 15E078, a remedy is currently being validated that would add a bracket covering the fan gear assembly and center bolt that would prevent the fan gear assembly from disengaging from the steps in the event that the center bolt were to fracture and reinforcing a stable platform.

All steps covered under this recall will be remedied free of charge.

Once OCC is advised of the proven remedy, OCC will update its Part 573 Report.

How Remedy Component Differs from Recalled Component : According to the Part 573 Report filed by Lippert, 15E078, the involved part numbers (128980; 64194; 165033; 165034; 165035; 165044; 168367; 171317; 171776; 173476; 234310) are no longer built and sold by Lippert Components. The last production and sale of the steps was December 2014. There is no future planned production of the recalled component.

Identify How/When Recall Condition was Corrected in Production : According to the Part 573 Report filed by Lippert, 15E078, the involved part numbers (128980; 64194; 165033; 165034; 165035; 165044; 168367; 171317; 171776; 173476; 234310) are no longer built and sold by Lippert Components. The last production and sale of the steps was December 2014. There is no future planned production of the recalled component.

Recall Schedule :

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
