To Whom It May Concern:

This notice is being sent in accordance with the requirements of the National Traffic Motor Vehicle Safety Act.

Great Dane Trailers has decided that a defect which relates to motor vehicle safety exists in certain Van Semi-Trailers manufactured by Great Dane between March, 2014 and October, 2014. The defect has to do with the Haldex Life Seal T3030 Long Stroke Brake Actuators which could cause brake drag, wheel end over heating, fire and or wheel off condition resulting in a loss of control or a crash.

To address and remedy this defect you should contact Great Dane Customer Service at 1-877-369-3493 to arrange through Haldex and the appropriate Great Dane Warranty service provider for the brake actuators to be inspected and/or replaced as necessary per Haldex procedures.

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.

If you conclude that Great Dane Trailers has not enabled you to remedy this condition without charge and/or in a reasonable time, a complaint may be submitted to the:

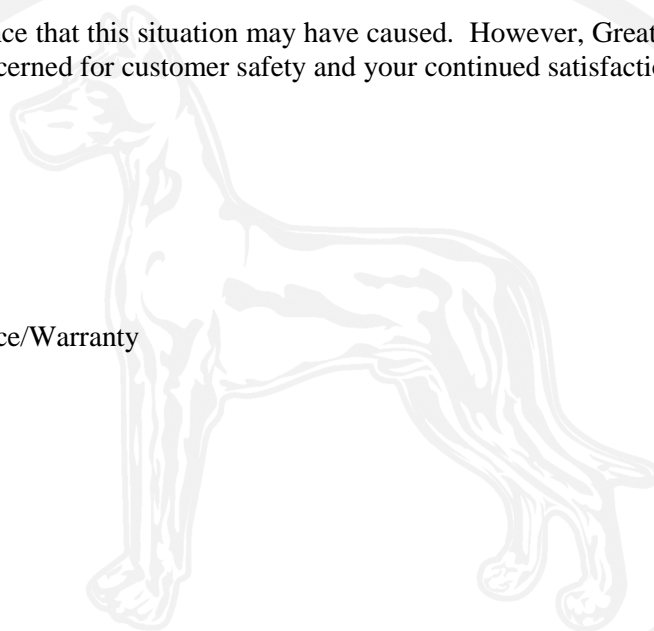
