## **IMPORTANT SAFETY RECALL**

### **PREMATURE FUEL TANK CORROSION: 15V-704**

**(Transport Canada 2015-203)**

**To:** All Isuzu Commercial Truck Service Managers and Parts Managers

This notice, Safety Recall bulletin CB16-L-001 with sample owner letters and an affected dealer stock report (if applicable) are being sent to notify you of this Safety Recall – Premature Fuel Tank Corrosion (15V-704)/TC 2015-203 in certain Isuzu commercial vehicles.

#### **AFFECTED VEHICLES**

- 2006-2008MY Isuzu NPR Series Vehicles
- 2006-2008MY Chevrolet/GMC W-Series Vehicles

Equipped with 6.0L Gasoline Engines

#### **CONDITION**

The manufacturer, Isuzu Motors Limited, has decided that a defect, which relates to motor vehicle safety, exists in certain Model Year 2006-2008 Isuzu N-Series and Chevrolet/GMC W-Series vehicles equipped with 6.0L gasoline engines. In the affected vehicles, certain fuel tanks may be susceptible to premature corrosion on the external surface of the tanks, which may result in a fuel leak, increasing the risk of a fire.

#### **CORRECTION**

Isuzu will replace the affected fuel tank with a new fuel tank, even if it was recently replaced. This service will be provided to the customer at **no charge**.

#### **PARTS**

An initial supply of required parts will be shipped to dealers in the salt belt region (i.e., Connecticut, Delaware, Illinois, Indiana, Iowa, Kentucky, Maine, Maryland, Massachusetts, Michigan, Minnesota, Missouri, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont, West Virginia, Wisconsin, and the District of Columbia) based on the affected vehicle population in their area. Those dealers can expect these parts to be delivered prior to the owner notification date.

When additional parts are needed, please place additional orders with AIPDN.

#### **VEHICLES INVOLVED**

Involved are *certain* 2006-2008 model year Isuzu N-Series and Chevrolet/GMC W-Series vehicles equipped with 6.0L gasoline engines.

#### **OWNER NOTIFICATION**

OWNER NOTIFICATION IN THE SALT BELT REGION AND CANADA WILL BEGIN APRIL 8, 2016. Note that owners in other regions will be notified when sufficient additional parts become available.

Please ensure that all appropriate personnel within your dealership are aware of this Safety Recall – Premature Fuel Tank Corrosion 15V-704 (TC 2015-203) and that the necessary repairs are performed on all affected vehicles either in your inventory or brought into your dealership for repair.
