BMW AG has decided that a defect, which relates to motor vehicle safety, exists in certain Model Year 2014-2015 BMW X5 Sports Activity Vehicles. Our records indicate that you are the owner of an affected vehicle.

DESCRIPTION OF PROBLEM



This recall involves the Head Protection System (HPS). The HPS air bag was not produced to specifications and therefore may not provide sufficient restraint capability in a crash when it deploys, increasing the risk of injury.
