



Important Safety Recall

This notice applies to your Hyundai Translead Trailers on BOM# 30008041, 30008954, 30009046, 30009142, 30009265 and 30009339.

December 01, 2015

Dear Mark Guard and Schneider Company,

As we previously informed you via e-mail, we are conducting a safety recall and this notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Haldex has decided that a defect which relates to motor vehicle safety exists on the Life Seal NG3 brake chambers.

Important!

- Your trailer falls within the recall population
- You should avoid use and immediately schedule an appointment with Haldex to have your Life Seal NG3 brake chamber replaced with a Gold Seal 3030 Long Stroke Model, and if necessary repaired.

Why is a recall being conducted?	Haldex reported that Hyundai Translead trailers that are equipped with a Haldex Life Seal NG3 Brake chamber might find a small internal air leak which bleeds air from the Spring Brake side to the Service Brake side causing a possible brake brag condition. If the leak is found it may lead to a brake failure increases risk of crash and there is also a risk of a wheel end fire.
What are we doing about the problem?	Haldex will be replacing the Life Seal NG3 Brake Chambers on affected trailers for new Gold Seal 3030 Long Stoke Models. Haldex has the new parts readily available and they also have the required repair instructions available. There will be no charge for this service. Replacing the brake chamber should take less than one hour at a shop.
What should you do?	Please contact Haldex at their Toll Free Hotline: 800-752-2501 as soon as possible to schedule an appointment. You should avoid extended travel until your Life Seal is replaced.
