**NHTSA RECALL #15V-297
Adding Relay to Slide Out Controller
2015 Phaeton 40QBH & 40QKH
2015 Allegro 38QBA & 36QSA**

Dear Tiffin Motorhome Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Tiffin Motorhomes has decided that a defect, which relates to motor vehicle safety, exists on the following models of motorhomes: 2015 Phaeton 40QBH and 40QKH, and 2015 Allegro 30QBA and 36QSA. It has been found that if moisture infiltrates the slide out controller that the "switch out" connection can become shorted indicating to the controller to open the slide out. In normal operation the signal to open the slide out is disabled while the vehicle is in transit. However, the slide out could possibly open due to the slide out controller being powered from a constant source and receiving this erroneous signal to open. If the slide out opens while in transit, this increases the possibility of a motor vehicle accident.

Tiffin Motorhomes is installing a relay to disconnect the slide out controller power source in the event that the connection becomes shorted out. This will prevent any power from going into the controller and the slide out will not be able to be opened.
