## Triple E Recreational Vehicles Recall CA#8132-1

This notice is sent to you in accordance with the requirements of the National Traffic & Motor Vehicle Safety Act. Triple E Recreational Vehicles has decided that certain 2015 & 2016 Unity Motorhomes manufactured between September 2014 & September 2015 fail to conform to Federal Motor Vehicle Safety Standard

### Description of Noncompliance:

The battery compartment is not sealed to the interior of the motorhome. The top angle iron used as a stop for the coach battery compartment there was no sealant put between the angle iron and the motorhome floor. Gasses from the battery may enter the motorhome when there is a negative pressure, increasing the risk of a fire.

### To Have This Modification Performed:

We request your assistance to have this noncompliance issue corrected. Your selling dealer will perform the needed correction. Please contact your selling dealer as soon as possible to arrange for an appointment to have this recall performed. The recall will be performed at no charge to you. The time needed to complete this repair is approximately 20 minutes.

**Federal regulations require that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.**

**If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.**
