

IMPORTANT SAFETY RECALL

R53 / NHTSA 15V-595

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA has decided that a defect, which relates to motor vehicle safety, exists in certain 2016 model year Chrysler Town and Country and Dodge Grand Caravan minivans.

The problem is... The hood striker retaining bolts on your vehicle may not have been tightened to the proper torque specification during the manufacturing process. If the hood striker retaining bolts completely detach from the hood, the hood will separate from the hood striker, allowing the hood to open. An open hood while driving could obstruct the driver's vision and cause a crash without warning.

What your dealer FCA will repair your vehicle free of charge. To do this, your dealer will properly tighten the hood striker bolts. The work will take about ½ hour to complete. However, additional time may be necessary depending on service schedules.

What you must do to ensure your Simply contact your Chrysler, Jeep service appointment. Please bring this safety...

Simply **contact your Chrysler**, **Jeep**, **Dodge or RAM dealer** right away to schedule a service appointment. **Please bring this letter with you to your dealer**.

If you've had previous repairs and/or reimbursement you may still need to have the recall repair performed on your vehicle.
