SUBJECT: Model 205 (C-Class), Model Year 2015 Retrofit Headlamp Adjustment Screw Caps

Daimler AG (DAG), the manufacturer of Mercedes-Benz vehicles, has determined that the headlamps might not meet the requirements of Federal Motor Vehicle Safety Standard (FMVSS) 108, which requires that headlamps with low beams must not have a horizontal adjustment mechanism. The subject vehicles are designed to meet this requirement by sealing off the headlamp horizontal adjustment screw with a non-removable sealing cap after initial adjustment in the manufacturing plant. The sealing cap may not have been installed on these vehicles. An authorized Mercedes-Benz dealer will retrofit the two sealing caps. This recall affects dealer inventory only. Affected vehicles must be repaired prior to sale or lease.

Prior to performing this Recall Campaign:

- Please check VMI to determine if the vehicle is involved in the Campaign and if it has been previously repaired.
- Please review the entire Recall Campaign bulletin and follow the repair procedure exactly as described.

Please note that Recall Campaigns **do not expire** and may also be performed on a vehicle with a vehicle status indicator.

Approximately 2,770 vehicles are involved.

Procedure

- 1. Open hood.
- 2. Retrofit cap (B, Figure 1) for headlamp adjustment screws (A) at left and right:
- Position cap (B, Figure 1) on headlamp adjuster (A) so that the tabs (arrows) on the cap (B) align with the grooves in the adjuster (A).
 - Press the cap (B) into adjuster (A) by hand until it locks into position.

An audible click will be heard when the cap (B) is properly seated into the adjuster (A).
