SECOND NOTICE

Dear Kenworth Customer,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Kenworth Truck Company has decided that a defect which relates to motor vehicle safety exists in certain 2014-2016 Kenworth T660, T680, T880 trucks manufactured February 18, 2013, to April 8, 2015. The affected trucks, equipped with PACCAR MX-13 engines and Delco-Remy 40SI alternators, have alternator charge cables that may chafe against a formed metal Freon discharge line.

If the alternator cable rubs through its insulation, an electrical short may occur, increasing the risk of a fire.

<i>The problem is...</i>	Alternator power cable rubs metal A/C Line
<i>What your dealer will do...</i>	Dealers will rotate cable and install a retainer
<i>What you must do ...</i>	Contact your Kenworth Dealer to schedule an appointment for repair

Kenworth has initiated a recall to rotate the alternator cable 180° and install a new retainer. This repair should take approximately **1.0 Hour** and will be performed at no charge to you. Please contact your Kenworth dealer immediately to schedule an appointment for this repair. To find your nearest Kenworth dealer, please visit Dealer Locator at www.Kenworth.com. If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
