### 15S28 - Shift Control Lever Bolt Torque

#### What is the Issue?

Our records indicate a Ford remanufactured transmission was installed in your vehicle. It may be possible that the shift control fastener on your transmission may not have been properly torqued. If the fastener becomes loose, the shift control lever may disengage from the transmission without warning and the transmission may not respond to the operator gear selection. This can result in possible vehicle roll-away, increasing the risk of an injury or crash.
