# What is the Issue?

On your vehicle, when the Adaptive Cruise Control (ACC) is engaged, the driver may experience unexpected braking while passing a large, highly reflective truck. The Collision Warning System red warning light may also flash and an audible tone may be heard at the same time. The brake lights will illuminate while the brakes are applied. The driver can override the ACC at any time using the accelerator pedal, brake pedal or by cancelling ACC through the steering wheel switches. The duration of this unexpected braking could increase the risk of a crash.
