IMPORTANT SAFETY RECALL – 15V-014

Dear Valued Customer,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Spartan Motors Chassis, Inc. has decided that a defect which relates to motor vehicle safety exists in certain motor home chassis.

Please note: The Vehicle Identification Number that may be affected by this recall is located at the top of this letter.

What is the defect?

Front sway bar mounting brackets may break causing the sway bar to detach from the mounting frame. Should the sway bar become detached without warning, increased vehicle sway may occur. This could increase the risk of a crash.

Corrective Action:

Existing mounting brackets will be replaced at no charge. However, these parts are not yet available. Therefore, the sway bar mounting brackets will need to be inspected by a Spartan Chassis authorized service center.

When the final remedy becomes available, you will receive a subsequent notice.



Labor Time:

An inspection of the sway bar mounting brackets may take 1 hour.

Due to some service scheduling times, your service center may need your vehicle for a longer period.

What You Should Do:

Call Spartan Chassis at 800-543-4277 opt 1 to locate a qualified service center near you. Steps will be taken to ensure the recall is performed at the nearest service center.

Leased Vehicles:

The lesser must notify the lessee by first class mail within ten (10) days from receipt of their owner notification letter from the manufacturer; both for the initial notification and all subsequent notifications.

Reimbursement:

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall. For more information contact Spartan Chassis at 800-543-4277 opt 1.

Reply Card:

Please fill out the enclosed prepaid postcard and mail it to us if you have changed your address, sold, or traded the vehicle.

If the authorized service center has failed or is unable to remedy the defect without charge and within a reasonable time, contact Spartan Chassis at 800-543-4277 opt 1.
