Your Vehicle Identification Number (VIN):

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ford Motor Company has decided that a defect which relates to motor vehicle safety exists in your vehicle, with the VIN shown above.

We apologize for this situation and want to assure you that, with your assistance, we will correct this condition. Our commitment, together with your dealer, is to provide you with the highest level of service and support.

What is the issue?

On your vehicle, pressure cycles within the fuel system may cause the surface of the fuel tank to develop a crack, which may result in a fuel odor or leak. A fuel leak in the presence of an ignition source can lead to a fire. A cracked fuel tank may also exceed the maximum allowable hydrocarbon evaporative emissions.

What will Ford and your dealer do?

Ford Motor Company is in the process of developing the parts for this repair. When the repair is available for Safety Recall 15S34, you will be notified by Ford Motor Company via mail to schedule a service appointment with your dealer to update the calibration in your vehicle's Powertrain Control Module (PCM), test or inspect your vehicle's Canister Purge Valve (CPV), vapor canister, and fuel tank, and replace any parts that do not pass. The PCM calibration update is anticipated to become available in the first quarter of 2016, and replacement fuel tanks are anticipated to become available in the third quarter of 2016.

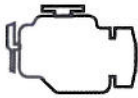
We apologize for any inconvenience these delays may cause you. We are working diligently to accelerate part availability.

This repair will be completed free of charge (parts and labor).

How long will it take?

The time needed for this repair is less than one-half day. However, due to service scheduling requirements, your dealer may need your vehicle for a longer period of time.

What should you do?



Malfunction Indicator Light

When the repair is available for Safety Recall 15S34, you will be notified by Ford Motor Company via mail to schedule a service appointment with your dealer.

Until the repair becomes available, **if your vehicle exhibits symptoms of a fuel odor, fuel on the ground, or illumination of the Malfunction Indicator Light (MIL)**, please contact your dealer immediately and request a service appointment for diagnosis and repair relating to Safety Recall 15S34. Provide the dealer with the VIN of your vehicle, which is printed near your name at the beginning of this letter.

If your vehicle does not exhibit these symptoms, no action is needed until you receive a follow up notification to schedule a service appointment.

If you do not already have a servicing dealer, you can access www.Fordowner.com for dealer addresses, maps, and driving instructions.

Until the repair becomes available, if you have any questions regarding this recall, feel free to contact Ford directly by calling 1-866-436-7332. Representatives are available to answer your questions.

Please note: Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

Do you need a rental vehicle?

If your dealer determines that your vehicle's fuel tank is leaking, your dealer is authorized to provide a rental vehicle for your personal transportation at no charge (except for fuel and insurance) while your vehicle is at the dealership for repairs. Please see your dealer for guidelines and limitations.

Have you previously paid for this repair?

If you have previously paid for a repair that addresses the issue described in this letter, you still need to have this recall performed to ensure the correct parts and procedures were used.

You may be eligible for a refund of previously paid repairs. Refunds will only be provided for service related to fuel tank replacement due to fuel leak, CPV replacement, and vapor canister replacement due to liquid fuel contamination. To verify eligibility and expedite reimbursement, give your paid original receipt to your dealer.

Refund requests may also be sent directly to Ford Motor Company. To request your refund from Ford, send the refund request with all required documentation, including your original repair receipt (no photocopies), to Ford Motor Company at P.O. Box 6251, Dearborn, Michigan 48121-6251. Refund requests mailed to this address may take up to 60 days to process. Your original receipt will be returned to you.

Detailed information regarding eligibility for Ford's reimbursement program and documentation requirements may be obtained by contacting the Ford Customer Relationship Center at 1-866-436-7332.

What if you no longer own this vehicle?

If you no longer own this vehicle, and have an address for the current owner, please forward this letter to the new owner.

You received this notice because government regulations require that notification be sent to the last known owner of record. Our records are based primarily on state registration and title data, which indicate that you are the current owner.

**California and
Massachusetts
Registration
Requirements**

The State of California and the Commonwealth of Massachusetts require the completion of emission-related recall repairs prior to vehicle registration renewal. If your vehicle is registered in California or Massachusetts, it is subject to these requirements.

When your dealer completes this emission-related recall repair, you will receive a Vehicle Emission Recall Proof of Correction certificate. **Please make sure that you receive a certificate from your dealer and that you have it with you when you renew your vehicle registration.**

It is also important for you to know that the certificate should be returned to the Department of Motor Vehicles (DMV) only if it is requested by the DMV. Otherwise, this certificate is to be held by you for your records.

In order to ensure your full protection under emissions warranty provisions, and to avoid any inconvenience when renewing your registration, it is recommended that you have your vehicle serviced as soon as possible. Failure to do so could be determined as lack of proper maintenance of your vehicle.
