Problem Description:

Bugatti is recalling certain model year 2006 Veyron vehicles manufactured March 10, 2006, to December 22, 2006. In the affected vehicles, the positive battery (B+) cable and the connection to the alternator may corrode.

Consequence:

The corrosion may result in the battery positive cable overheating, increasing the risk of a fire.

Remedy:

All affected vehicles have had the battery B+ cable and the alternator replaced, free of charge. Owners may contact Volkswagen of America at 1-248-754-5000.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

The information in your report suggests that Bugatti may have been aware of this issue more than five business days before filing a report with NHTSA. Please be reminded that under Federal law, this agency is to be notified of all safety defect and/or noncompliance decisions within five business days. 49 CFR 573.6

Since you state that all affected vehicles have been remedied, please submit one quarterly report listing a one-hundred percent completion rate.
