This letter serves to acknowledge Autocar, LLC's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

Autocar, LLC (Autocar) is recalling certain model year 2016-2017 Xpeditor vehicles manufactured March 04, 2016, through April 21, 2016. The tab lock washers on the rear axle wheel ends may not have been properly bent over the outer spindle nut during assembly.

Consequence:

If the spindle nuts loosen, the wheel assembly may separate from the rear axle, increasing the risk of a crash.

Remedy:

Autocar will notify owners and dealers will inspect the tab lock washers and remedy tabs where needed, free of charge. The recall is expected to begin on June 30, 2016. Owners may contact Autocar's customer service at 1-765-489-5499. Autocar's number for this recall is ACX-1602.

We have received Autocar's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
