Chronology:

Daystar Products International, Inc. ("Daystar") began shipping aftermarket kit KJ09168BK for the 2016 Jeep Renegade on 11/1/2015 which contained rear control arm brackets supplied by Northwest Technologies, Inc. On or about December 1, 2015 Daystar inspected and rejected welding on a rear control arm bracket intended for use in a subsequent shipment of kits. On 2/1/2016 Daystar was notified by a customer in Italy regarding what was described as a broken weld in a rear suspension bracket. Between 2/2/16 and the date of this report, Daystar's investigation indicates the Italian customer purchased his kit from a U.S. retailer, the kit purchased was part of the initial kits distributed by Daystar and the kit purchased included rear control arme brackets sent by Northwest Technologies to Daystar on October 27, 2015.

Description of Remedy:

 $Description\ of\ Remedy\ Program: Daystar\ will\ request\ end\ customers\ to\ inspect\ all\ rear\ control\ brackets$

included in its initial shipment and will replace any brackets with incomplete filet welds. Daystar customers are typically experienced off road enthusiasts/mechanics who self-installed the KJ09168BK kit. If a customer is unwilling/unable to self-inspect/repair, Daystar will direct the customer to a repair shop where inspection/replacement can be done and provide a labor reimbursement of up to .6 hours. Daystar believes a portion of the recalled brackets/kits remain in wholesale distributors inventory and will be exchanged. Daystar will reimburse any customers who have completed inspection or repairs prior to receiving notification of this campaign.

How Remedy Component Differs from Recalled Component: The remedy/replacement rear control arm bracket will be marked with an identifying code.

Northwest Technologies, Inc. to confirm required filet welding and instituted a physical inspection of inventory and all rear control arm brackets received from Northwest Technologies.
