Description of Remedy Program : Conduct a Safety Recall on all affected vehicles to provide wheel chocks to vehicle owners. The wheel chocks will be installed with the vehicle's spare tire in such a manner that they must be removed before the spare tire is removed from its stowed location. FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
