Description of the Defect : Some Volkswagen Routan vehicles may experience an occupant restraint controller (“ORC”) malfunction resulting in an illuminated airbag warning lamp with the possibility all restraint systems, including airbags, may not deploy in the event of a crash, or an inadvertent air bag deployment without prior illumination of the airbag warning lamp.

FMVSS 1 : NR

Description of the Safety Risk : If the airbag warning lamp is ignored, and the ORC is not replaced, all restraint systems, including the airbags may not deploy in a crash, which could increase the risk of serious injury or death. In the event of an ORC malfunction resulting in inadvertent deployment of the airbags, the risk of a crash and/or injuries could be increased

Description of the Cause : Reference Chrysler Recall (NHTSA 16V047)
