**Description of Defect :**

Description of the Defect : According to a notification received from Freedman Seating, it has discovered a potential safety issue that may be present in Family Seat, Family 3pta, and ICS Integrated Child Seats that were shipped between January 15, 2016 and January 29, 2016. Specifically, Freedman has learned that a shipment of fasteners received by Freedman on January 15, 2016 was defective, causing a reduction in their strength. The subject mechanical fastener, Hex head cap screw, 3/8" – 24 x 1, grade 8.

Description of the Safety Risk : The notification sent by Freedman Seating to Forest River, Inc. did not describe the potential safety risk and stated only that "a shipment of fasteners received by Freedman on January 15, 2016 was defective, causing a reduction in their strength".

Description of the Cause : According to its notification to Forest River, Freedman Seating learned that a shipment of fasteners received by Freedman on January 15, 2016 was defective, causing a reduction in their strength. The subject mechanical fastener, Hex head cap screw, 3/8" – 24 x 1, grade 8.
