Description of Defect:

Description of the Defect : Jaguar Land Rover was informed by Key Safety Systems Inc. (KSS) of the risk of a

safety defect with drivers airbag supplied since 2008 for installation into certain Jaguar vehicles. KSS notified National Highway Traffic Safety Administration (NHTSA) though a Safety Defect report - Equipment Report Transaction ID: 1600103941770910 submitted on April 04, 2016. The defect described in the KSS report is 'Due to the absence of the chemical enhancer required for the second stage/high output deployment of the driver airbag, the second stage of the airbag will not deploy properly in certain high speed crash conditions. This condition does

not affect primary stage airbag deployment'.

Description of the Safety Risk: The safety risk in the KSS reports states 'If the vehicle is involved in a high

speed crash that triggers the second stage deployment of the driver frontal airbag, the second stage will not fill as fully as intended for this crash condition.

This increases the risk of injury to the driver, particularly unbelted drivers'.

Chronology:

KSS notified Jaguar Land Rover of the possibility of a safety defect relating to parts supplied on April 04, 2016. A Product Safety and Compliance Committee (PSCC) investigation was raised on April 05, 2016 where the scope and impact of this matter was discussed.

KSS provided Jaguar Land Rover in the week of April 4, 2016 details of the driver airbag module serial numbers identified by them as being potentially defective. A completed list of driver airbag module serial numbers was provided on April 07, 2016. From this list of serial numbers the affected vehicles were identified. All at risk parts identified by KSS were supplied to the vehicle assembly plant and none to the after-market.

The concern was further reviewed at the PSCC on April 12, 2016 where the scope was clarified and numbers of vehicles defined. On April 12, 2016 Jaguar Land Rover senior management agreed with the confirmation that Jaguar Land Rover has vehicles with the identified defective KSS driver air bag modules and that a voluntarily safety recall be conducted.

Description of Remedy Program: Owners will be notified and instructed to take their vehicles to a Jaguar authorized repairer who will fit a replacement driver's airbag.
