Description of the Safety Risk: Due to the functionality, the switch may be more susceptible to an

unintentional actuation, which could lead to unintended auto-closure of the

roof panel, increasing the risk of injury.

Description of the Cause: The switch is not sufficiently recessed to prevent actuation from a 20 mm radius

sphere for certain panoramic roof operation cycles. (Testing requirement according

to FMVSS No. 118.)

Chronology:

A test conducted on April 13, 2016 demonstrated that the power-operated roof panel system in a preproduction vehicle of the new S90 model would auto-close when pressing the switch in the overhead console and the roof panel is open. Due to the functionality, the switch can be actuated when performing the test procedure set forth in S6 (a) of FMVSS No. 118, which results in the roof panel auto-closing when open.

Since the functionality may have been used in the XC90 model year 2016 vehicles, Volvo Cars opened an investigation into this issue.

On April 27th, 2016, Volvo Cars Critical Concern Management Team (CCMT) decided to conduct a non-compliance recall, concerning model year 2016 XC90 vehicles.
