Description of Defect :

Description of the Defect : Updated December 7, 2018: This submission is to inform the Agency of Ford's intent to implement the "Other" report category for removed vehicles in Quarterly Reporting as permitted in the Third Amendment to the Coordinated Remedy Order (ACRO3), paragraphs 45 through 49. As a condition of ACRO3, all affected vehicles will remain active, or "live," across Ford's data systems such that any search of "Other" removed VINs will return an open recall status. For this reason, the number of potential involved vehicles in this report will remain the same. However, for reference, initial counts of vehicles in the "Other" reporting category are indicated in the attached supplement. Note that these counts are current as of fourth calendar quarter of 2018. Future changes to overall Total Removed counts, including "Other" will be reflected in quarterly reporting.

The passenger frontal airbag inflator could rupture if the vehicle is involved in a crash where the supplemental frontal airbags are designed to deploy. This defect report is in response to Takata DIRs 16E-042, 16E-043, 16E-044.

Description of the Safety Risk : The passenger frontal airbag inflator could rupture if the vehicle is involved in a crash where the supplemental frontal airbags are designed to deploy.

Description of the Cause : The Agency has concluded that the rate at which propellant degradation may occur in non-desiccated ammonium nitrate based frontal airbag inflators varies based upon geographic factors of environmental heat and humidity. In light of the Agency's findings, NHTSA has concluded that at some point in the future all non-desiccated frontal Takata PSAN inflators will reach a threshold level of degradation that could result in the inflator becoming unreasonably dangerous.

Chronology :

On May 3, 2016, the Agency issued an Amendment to the November 3, 2015 Consent Order in EA15-001. The Agency has concluded that the rate at which propellant degradation may occur in non-desiccated frontal airbag inflators varies based upon geographic factors of environmental heat and humidity. In light of the Agency's findings, NHTSA has concluded that at some point in the future all non-desiccated frontal Takata PSAN inflators will reach a threshold level of degradation that could result in the inflator becoming unreasonably dangerous.

On May 16, 2016, Takata issued three Defect Information Reports (16E-043 – Zone A, 16E-042 – Zone B, and 16E-044 – Zone C) in accordance with the terms specified in the May 4, 2016 Amendment to the November 3, 2015 Consent Order in EA15-001. Takata is not aware of any test ruptures in ballistic testing or confirmed field incidents of the subject non-desiccated ammonium nitrate inflators other than those already under recall. Out of an abundance of caution, Takata filed the DIRs in cooperation with NHTSA to promote public Safety.

On May 27, 2016, Ford's Field Review Committee reviewed the concern and approved a field action.

August 30, 2016: Ford updated affected vehicle counts with latest IHS-Automotive registration information for the Recall Zones.

March 1, 2019: The manufacturer's identification code for this action was changed from 16S26 to 19S01.

Description of Remedy :

Description of Remedy Program : Owners will be notified by mail and instructed to take their vehicle to a Ford or Lincoln dealer to have their passenger frontal airbag inflator replaced. There will be no charge for this service.

Ford will forward a copy of the notification letters to dealers to the agency when available.
