Description of the Defect : Daimler Trucks, the manufacturer of the chassis of the affected vehicles, submitted a Defect Information Report. Related to "ZF IFS Front Axle Steering Gears." According to the Daimler and ZF submissions to NHTSA, ZF reported "The steering box type 8018 as a subcomponent delivered from Bosch is mounted into a subframe including the front axle (Independent Front Steering Axle). This subcomponent has its own part no. allocated by Bosch. A wrong spacer from the steering box type 8016 was installed into the version 8018 and the insufficient height can result in too much play. The consequence will be that within an undefined period, the connection will wear out."

Description of the Safety Risk : According to the Daimler and ZF submissions to NHTSA, "the defect could lead to a loss of mechanical connection between the steering wheel and the front axle wheels. This could lead to a loss of control of the vehicle."

On May 25, 2016, Forest River's Glaval facility received an electronic notice from Daimler Trucks North America LLC regarding a defect related to "ZF IFS Front Axle Steering Gears".

On May 26, 2016, Forest River's Office of Corporate Compliance ("OCC") received the notice from the Glaval facility and determined that it would submit a recall notification on this issue.
