Description of the General Motors has decided that certain 2016 Chevrolet Equinox and GMC

Noncompliance: Terrain vehicles may not comply with Federal Motor Vehicle Safety Standard

(FMVSS) No. 110, "Tire Selection and Rims for Motor Vehicles." Incorrect certification labels may have been affixed to these vehicles. If the certification labels are incorrect, the tire/rim size and cold tire pressure information on the

certification label may be inaccurate.

Description of the Safety Risk: If a customer uses the incorrect tire/rim size and cold tire pressure

information on the certification label, the customer may use the wrong tire/rim size or improperly inflate the tires, which could affect the driver's ability to control the vehicle in certain situations and could increase the risk of a

crash.

Description of the Cause: The assembly plant did not follow the proper repair confirmation process to

confirm that the replacement certification labels were installed on the correct

vehicles.

Chronology:

On May 4, 2016, GM was notified that a customer's 2016 MY Chevrolet Equinox may have an incorrect VIN printed on the certification label. The certification label's VIN did not match the VIN on the plate under the front windshield. GM analyzed the certification label's VIN and determined that it belonged to an unsold vehicle still on a dealer's lot in Colorado.

On May 5, 2016, GM contacted the dealer in Colorado about the suspect vehicle. The dealer inspected the unsold vehicle and found the same issue—the VIN on the certification label did not match the VIN on the plate under the front windshield. The VIN on the plate under the windshield matched the VIN on the first vehicle's certification label, which indicated that the certification labels were applied to the wrong vehicles. GM analyzed the certification label VIN of the unsold second vehicle and confirmed that it belonged to a vehicle that had already been sold to a customer. On May 6, 2016, the issue was submitted as a potential noncompliance issue through GM's Speak Up For Safety program. On May 23, 2016, GM opened an investigation.

Between May 25 and June 5, 2016, GM investigated the vehicles with suspect certification labels and determined that they were among 18 sequential vehicles built on October 16, 2015 that had their certification labels reprinted and reapplied during assembly because the original labels were improperly installed (wrinkled). The tire/rim size and cold tire pressure information on the certification labels is also included on a tire label that is located next to the certification label in the driver's door frame. Based on GM's investigation, the tire labels on the suspect vehicles were properly applied and include the correct tire/rim size and cold tire pressure information.

The investigation was reviewed in GM's Open Investigation Review on June 6, 2016, and on June 9, 2016, GM's Safety and Field Action Decision Authority decided to conduct a noncompliance recall.

Description of Remedy:

Description of Remedy Program: Dealers will inspect, and if necessary, replace the certification label.
