Description of Defect:

Description of the Defect: General Motors has decided that a defect which relates to motor vehicle safety

exists in 2014-2016 model year Chevrolet Caprice Police Pursuit Vehicles (PPVs) and Chevrolet SS vehicles. The flexible steel cable that connects the safety belt to the vehicle at the outside of the front driver seat can fatigue and separate over time if the driver's movement into the seat repeatedly bends the

steel seat belt cable down against the seat edge.

FMVSS 1: NR FMVSS 2: NR Description of the Safety Risk: In a crash, a fatigued cable could break, reducing the effectiveness of the

vehicle's safety belts and increasing the risk of injury to the occupant.

Description of the Cause: In certain seating positions, the safety belt's flexible steel cable (or "tensioner

cable") can be located in a forward position allowing the occupant to sit on top of it while entering the vehicle. This action can bend the steel cable over the seat side shield, which over time may cause the cable to fatigue and separate.

Identification of Any Warning The covering on the tensioner cable may show visible signs, including tears,

that can Occur: holes, or wear marks.

Chronology:

On February 3, 2016, a GM Brand Quality Manager filed a Speak Up for Safety Report after a review of warranty data indicated a broken seatbelt lap anchor tensioner cable on a 2014 Chevrolet SS vehicle. On February 24, 2016, a formal investigation was opened. The issue was presented at GM's Open Investigation Review ("OIR") on April 25, 2016, and further investigation into field incidents, including on police pursuit vehicles, was requested. Additional testing was conducted in May, 2016 and further field failures were discovered on June 15 and 16, 2016. The investigation was brought back to OIR on June 27, 2016, and on June 29, 2016, GM's Safety Field Action Decision Authority ("SFADA") decided to conduct a safety recall.

Description of Remedy:

Description of Remedy Program: Dealers will inspect and, if necessary, replace the tensioner cable

assembly. For vehicles that do not require tensioner assembly

replacement, a cable guide will be installed. All vehicles will receive new seat trim with a redesigned opening for the cable routing. Pursuant to 577.11, GM will provide reimbursement to owners for repairs completed on or before ten days after the owner mailing is completed, according to

the plan submitted on May 20, 2015.
