Description of the Noncompliance : The shower door installed in the vehicles may not meet FMVSS 302 (Flammability) requirements.

FMVSS 1 : 302 - Flammability of interior materials

FMVSS 2 : NR

Description of the Safety Risk : Failure to meet the requirements of FMVSS 302 could enhance the spread of a flame in the event of a fire.

Description of the Cause : The manufacturer of the shower door did not ensure the product complied with the requirements of FMVSS 302.

On July 12, 2016, Forest River's - Office of Corporate Compliance ("OCC") was contacted by the manufacturer of the shower door, SEA/PRAXIS, regarding a potential issue where the manufacturer sold versions of the shower door which were not certified to meet the requirements of FMVSS 302 (Flammability).

On July 14, 2016, Forest River initiated its investigation into this issue to ascertain the make and model of the vehicle(s) included with this non-compliance.

On July 15, 2016, Forest River decided to conduct a recall for the potential noncompliance described above. Forest River is not aware of any accidents or injuries associated with this issue.

Description of Remedy :

Description of Remedy Program : SEA/PRAXIS, will provide Forest River Dealers with compliant FMVSS 302 shower doors directly, free of charge to both Owner and Dealer. Forest River Dealerships will conduct the repairs, free of charge.

How Remedy Component Differs from Recalled Component : According to SEA/PRAXIS, the shower door has been modified to pass the required FMVSS 302 Certifications by a change in the textile used.

Identify How/When Recall Condition was Corrected in Production : According to SEA/PRAXIS, the new shower door has been tested to and meets the requirements of FMVSS 302.

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
