Description of the Noncompliance : The flexible pvc shower door installed is not FMVSS 302 compliant. Shower Enclosures America (SEA) has filed a recall for their affected product.

FMVSS 1 : 302 - Flammability of interior materials

FMVSS 2 : NR

Description of the Safety Risk : In the event of a fire, the PVC shower door curtain would burn a faster rate than allowed by FMVSS 302.

Description of the Cause : The flexible PVC used during the manufacturing process of the shower door is not FMVSS 302 compliant.
