Description of the Defect : Independent testing initiated by E.V.S. Ltd. has revealed that certain seat tracks furnished by Dometic Corporation during the aforementioned date range, may be impaired by a defect which allows the seat track to release unexpectedly in the event of rapid deceleration.

Description of the Safety Risk : In the event of an accident, such release could allow the seat to move forward

Description of the Safety Risk : at a high rate of speed. This may increase severity of injury or death. The defect does not increase the likelihood of a crash in any way.
