Description of the Noncompliance : The subject vehicles' Federal Placards indicate an incorrect Tire and Rim combination. The Federal Placard indicates ST225/75R15D Tires with 65 PSI and a rim designation of 15X6.0JJ, while the subject vehicles received ST205/75R14C Tires with 50 PSI and a rim designation of 14X5.5JJ.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : NR

Description of the Safety Risk : The operator may over-inflate the tire based on the information printed on the Federal Placard. Overinflating a tire may lead to pre-mature tire degradation, a tire blowout, reduced handling, and a potential of a crash.

Description of the Cause : The incorrect tire and rim combination package was selected which led to incorrect information being printed on the Federal Placards.

On September 30, 2016, Forest River's Office of Corporate Compliance ("OCC") was made aware of a potential issue involving the tire and rim combination by the engineering staff at the plant. OCC started an internal investigation to understand better the issue including what the tire, rim, and axle rating(s) should be, and what had been printed on the Federal Placard.

On October 5, 2016, OCC had a completed its investigation. On October 7, 2016, the Corporate Committee that it would conduct a recall of the affected vehicles.

Description of Remedy :

Description of Remedy Program : Forest River will provide the Owner and Dealer of current record with the new Federal Placard for installation, free of charge.
